Approximately \$603,000, \$524,000, and \$795,000 were spent on curatorial, conservation and exhibitions; education and public programs, and maintenance and security, respectively.

During the year, the Art Museum purchased renovation capital assets totaling approximately \$3,137,000 which was transferred to the Columbia Museum of Art Commission.
